



#### **BOARD CANDIDATES: PAM HEAVENS**

Ms. Heavens works at United Cerebral Palsy's Center for Disability Services as a Community Access Advocate.

Ms. Heavens has been involved with the disability rights/independent living movement for 37 years, 28 of these years, she served as the Executive Director of the Will-Grundy Center for Independent Living in Joliet. She is active in the PPE for People with Disabilities Coalition (PPE4PWD), the Saving Institutional Lives Via Emergency Relocation Coalition (SILVER), the Patients' Rights Action Fund which opposes physician-assisted suicide) and the Institional Rescue & Recovery Coalition (IRRC).

Ms. Heavens helped establish the Will-Grundy Center for Independent Living in Joliet and served as the Executive Director for 27 years. While there, we filed and won seven housing discrimination cases related to new construction, helped Joliet pass a strong accessibility ordinance, and kept up to date on disability issues.

### **BOARD CANDIDATES: PAM HEAVENS**

In her words "I have had the pleasure of advocating with some of the PCIL staff members for the past few years. They are dedicated advocates with impressive results. Being a member of the Board would be a huge honor for me. I will put my experience to use in helping PCIL continue to grow as a strong advocacy-centered Center for Independent Living".

Ms. Heavens can contribute to the Progress Board with her skills and contacts such as Writing letters to the editors, familiarity with some state and federal legislators, and fundraising ideas along with advocacy skills.

#### **BOARD CANDIDATES: DEBBIE PITMANN**

Ms. Pittman is a member of the National Federation of the Blind of Illinois and Concerned Citizens of Paratransit. She can also produce materials in large print and Braille through Pittman Enterprises & Associates NFP. In addition, she has knowledge and resources regarding W3C accessibility communication standards.

In her own words, "Throughout the years, I have shown myself to be a strong advocate for diversity, equity and inclusion to ensure a level playing field for a diverse group of individuals through technological advances focusing on accessibility. In addition, I possess a strong work ethic and determination to be the best at what I put my mind to and have shown myself to be an excellent team player".

Ms. Pittman would like to once again work side-by-side with Progress Center to help improve the lives of people with disabilities.

She is also interested in helping with nominating, outreach/membership and program development.

Riley Spreadbury is currently a graduate student at the City University of New York enrolled in the online Disability Studies program. Additionally, she is a student at Moraine Valley Community College where I am working on my certificate in American Sign Language and Deaf Studies.

Mrs. Spreadbury is a member of the Disability and Access Coalition where she is running for a leadership position. She is a member of the Disability Rights Action Coalition for Housing. She is also a volunteer through the Lincoln Way Special Recreation Association where she has been able to touch base with many disabled residents of the Chicagoland area.

In her words, "As a disabled woman who has spent most of my life in Suburban Cook County, I feel I have a good understanding of the issues disabled residents face here as it relates to independent living. Through both my graduate and certification programs, I have also been learning extensively about the disability rights movement, the history of disabled people in the United States, and how these two concepts relate to each other. That, and the fact that my undergraduate degree is in Therapeutic Recreation, has provided me an opportunity to look at disability from multiple perspectives."

### Cook County Dept of Public Health -- Covid-19 Case Data as of June 17,2022:

- 193 Cases per 100,000 Last 7 Days
- 6.6 Hospital Admissions per 100,000 Last 7 Days
- 4.6% Hospital Beds Occupied by Covid-19 Patients
- LOW Suburban Cook Community Level



## REPORTS: PANDEMIC UPDATE

### COVID-19 Vaccines Administered to Suburban Cook County Residents of June 17, 2022:

- 1,995,649 People with at least one vaccine dose
- 1,518,055 People with complete vaccine series
- 690,170 Fully vaccinated people with a booster
- 87.3% Percent of total population with at least one vaccine dose
- 66.4% Percent of total population with complete vaccine series
- 45.5% Percent of fully vaccinated with booster



### PANDEMIC **UPDATE: AT** HOME COVID TESTS THAT ARE ACCESSIBLETO BLIND LOW VISION



The Biden-Harris Administration has launched a new initiative to expand the availability of at-home tests that are more accessible for people who are blind or have low vision. The tests work with a Bluetooth-enabled smartphone/tablet app to provide users with audible instructions, and audible test results.

#### How to get the tests:

- Order <u>online</u> or by calling 1-800-232-0233.
- Because supplies are limited, please order the more accessible tests only if you
  do not have options for using the standard tests.

#### **Need more assistance?**

- The trained staff at the Disability Information and Access Line (DIAL) can provide additional assistance with:
- Ordering tests.
- Understanding instructions for test administration and test results.
- Providing alternative instructions for traditional at-home tests for people who are unable to access, read, or understand the manufacturer's version.
- For those who cannot use an at-home test, DIAL operators can:
  - Assist with ordering "swab and send" kits to collect a sample and mail it back for results.
  - Connect callers to local organizations for assistance locating other testing options in their community, including in-home testing programs or transportation or companion support to visit a community-based testing site.

- Community-Based Organizations are eligible for K95 Mask Donations
- Staff continue to work in coalition (PPE for People with Disabilities Coalition) on implementation of SB 921
- Staff can assist with setting up test and vaccine appointments
